# TERMS AND CONDITIONS

## PLEASE READ THOROUGHLY

1. UNLESS OPTION #3 IS CHOSEN, WATER IN POOL MUST BE BELOW THE SKIMMER AT TIME OF WINTERIZATION, OR AN **ADDITIONAL CHARGE WILL BE ADDED TO THE WINTERIZATION**
2. VACUUMING OR CLEAN UP OF POOL IS NOT INCLUDED IN WINTERIZATION.
3. UNDER THE SERVICES MENTIONED, YORKTOWN POOL CO. WILL NOT BE RESPONSIBLE FOR LOOSE TILE, CRACKED COPING OR DAMAGED COVERS DUE TO ANIMALS, VANDALISM OR ACTS OF GOD.
4. YORKTOWN POOL CO., INC. WILL NOT BE RESPONSIBLE OR LIABLE FOR DELAYS IN CONTRACT DATE CAUSED BY WEATHER CONDITIONS, STRIKES, ACTS OF GOD OR OTHER CIRCUMSTANCES BEYOND OUR CONTROL, NOR ANY ENSUING DAMAGES CAUSED BY SAID DELAYS.
5. ANY ADDITIONAL CHEMICALS AND/OR REPLACEMENT PARTS NEEDED TO COMPLETE CONTRACT **WILL BE CHARGED IN ADDITION TO CONTRACT.**
6. YORKTOWN POOLS CO., INC. WILL NOT BE RESPONSIBLE FOR DAMAGES INCURRED BY OWNER'S FAILURE TO COMPLY WITH RECOGNIZED SUGGESTED PROCEDURES FOR PROTECTION OF SWIMMING POOL AND ITS EQUIPMENT THROUGHOUT THE SEASON FOR WHICH IT IS USED.
7. ALL WORK TO BE COMPLETED IN A SUBSTANTIAL, WORKMANLIKE MANNER. ANY AND ALL COMPLAINTS ARE TO BE REPORTED TO OUR OFFICE WITHIN 24 HOURS OF SERVICE. (717-792-3541 EXT 2)
8. FUTURE SERVICES, BEYOND A TEN (10) DAY LIMIT PERTAINING TO SERVICE PROVIDED, WILL BE SUBJECT TO A MINIMUM SERVICE CHARGE.
9. CUSTOMER IS RESPONSIBLE FOR MAINTAINING THE COVER AND WATER LEVEL AFTER SERVICE IS COMPLETED.
10. **PAYMENT IS DUE AT THE TIME OF SERVICE. IF PAYING BY CREDIT CARD, WE MUST HAVE THE CARD NUMBER AND EXPIRATION DATE PRIOR TO THE SERVICE. IF YOU CHOOSE TO PAY CASH OR CHECK YOU CAN PREPAY OR YOU MUST BE HOME TO PAY THE TECHNICIANS, OR LEAVE A CHECK (MADE OUT FOR THE BASE PRICE OF THE CHOSEN CLOSING) IN A ZIPLOCK BAG TAPED TO THE FILTER TANK. ANY BALANCE THAT MAY REMAIN DUE WILL BE INVOICED.**

## WINTERIZATION

### MAY WE SUGGEST THE FOLLOWING EASY STEPS

1. SIGN CONTRACT AND COMPLETE TOP PORTION, CHECKING OFF ALL SERVICES DESIRED.
2. IF YOU WISH, YOU MAY SPECIFY A PARTICULAR DATE FOR PREFERRED SERVICE DATE. EXAMPLE: WED. 9-24-22. EVERY EFFORT WILL BE MADE TO ACCOMMODATE YOUR WISHES. EARLY RETURN OF THIS CONTRACT WILL HELP ASSURE THIS.
3. IF WATER NEEDS TO BE LOWERED, DO SO OR CALL OUR OFFICE TO UPGRADE YOUR SERVICE PRIOR TO YOUR SERVICE DATE.
4. **WE CAN NOT GUARANTEE ANY APPOINTMENT TIMES ANYMORE. THE ONLY THING WE CAN DO IS GIVE YOU A 3 HOUR WINDOW OF TIME. THEREFORE, WE DO NOT RESERVE ANY TIME SLOTS. IT IS TOO HARD TO ROUTE OUR DAYS TO ACCOMATE THIS. WE ARE SORRY IF THIS INCONVIENCES OUR CUSTOMERS. OUR ROUTES HAVE JUST BECOME SO BIG WITH THE ADDED NEW CUSTOMERS OVER THE YEARS IT HAS BECOME A STRAIN ON TRYING TO FIGURE OUT HOW TO HANDLE APPOINTMENTS SO WE FOUND IT BEST TO DO IT THIS WAY. CUSTOMERS DO NOT NEED TO BE HOME FOR US TO TAKE CARE OF YOUR SWIMMING NEEDS. WE JUST NEED TO HAVE ACCESS TO THE POOL AND POWER.**
